5 - Her legacy: building bridges between caring and technology, ensuring nursing has a powerful voice in the digital future of health.


Dr. Marion J. Ball is one of the world's most influential voices in nursing and health informatics. Currently the Raj & Indra Nooyi Distinguished Chair in Bioengineering and Executive Director of MICHI at the University of Texas at Arlington, she has shaped the way technology and nursing come together to improve health care.

A former President of IMIA and Professor Emerita at Johns Hopkins University, Dr. Ball has spent decades advancing electronic health records, nursing education, and interprofessional collaboration. Her landmark books—Nursing Informatics: Where Caring and Technology Meet and Introduction to Nursing Informatics—remain foundational texts across the globe.

Widely honoured, including induction into the National Academy of Medicine and the Morris F. Collen Award, Dr. Ball continues to champion the principle that technology must serve people—empowering nurses, enhancing care, and driving innovation worldwide.

In 2025 The International Medical Informatics Association created the Marion J. Ball, EdD, FLHIMSS, FCHIME, FAAN, FACMI Leadership Award, honouring The University of Texas at Arlington's distinguished professor Marion Ball for her decades of global impact on health informatics. She also received the inaugural award at IMIA's international conference in Taipei.

Inge Madsen Associate Professor at VIA University, Aarhus, Denmark – Nursing Informatics Pioneer

Celebrating a Decade of Leadership and Contribution (2015–2025)

Associate Professor **Inge Cort Madsen** has been a driving force in nursing informatics for more than three decades. Serving as Denmark's Country Representative to IMIA-NI from 2015 to 2025, she has been an outstanding advocate for advancing nursing informatics and strengthening international collaboration.

Inge's engagement with IMIA began in 1994, when she presented her first poster in Texas. Since then, she has been an active contributor at numerous NI conferences as a speaker, mentor, and collaborator. As past chair of the EFMI Working Group for Nursing Informatics, she has promoted mentorship, leadership, and professional development for early-career nurses — a commitment she considers her highest priority.

Building Connections and Supporting the Next Generation

During the COVID-19 pandemic, Inge co-founded an international initiative with Ann Kristin Rotegård and Diane Skiba to support informatics-interested nurses. This collaboration produced shared educational tools and resources, fostering a global network of learning and support.

A Lifetime of Leadership in Nursing Informatics and Health IT

Dr. **Judy Murphy** is a globally recognised pioneer in health informatics, whose visionary leadership has shaped nursing informatics as both a profession and a movement. From her early advocacy for patient-centric technology in the 1980s to her executive leadership roles in health systems, government, and global industry, Judy has consistently advanced the integration of digital innovation into nursing practice and healthcare transformation.

Serving as **United States Country Representative to IMIA-NI (2016–2021)**, Judy's influence within IMIA-NI spans decades. She has presented, chaired, and contributed to every major Nursing Informatics World Congress since 1988, demonstrating her enduring commitment to international collaboration and knowledge exchange.

Transforming Practice Through Technology and Policy

Throughout her career, Judy has been a catalyst for meaningful health IT adoption and the advancement of nursing leadership in digital health. At **Aurora Health System**, she pioneered clinical and administrative informatics applications and championed patient-centred technologies during the formative years of the discipline.

Her leadership extended to the U.S. Department of Health and Human Services, where she served as Chief Nursing Officer and Director, Office of Clinical Quality and Safety, and Deputy National Coordinator for Programs and Policy at the Office of the National Coordinator for Health IT (ONC). In these roles, she ensured that health information systems were accessible to all healthcare facilities, including rural and critical access hospitals, and led major national initiatives such as the "Blue Button: Download Your Health Data" campaign and the creation of the Office of Consumer eHealth.

At IBM, Judy continued to shape the future of digital health by leading the Global Healthcare Provider Strategy, advising major international systems including the Dubai Health Authority and Singapore Ministry of Health. She currently serves as Co-Chair of the U.K. National Health Service CNIO Group, fostering cross-border collaboration and professional development.

Contributions and Recognition

Judy's impact extends through her leadership in **AMIA**, **HIMSS**, and the **Institute of Medicine** (now the National Academy of Medicine), where she spearheaded the *Roundtable on Value & Science-Driven Healthcare* and the *Digital Learning Collaborative*.

A prolific author with over **100 publications**, Judy is a sought-after keynote speaker at national and international conferences and continues to mentor nurses and informaticians around the world. Her numerous fellowships and lifetime achievement awards reflect her enduring influence and thought leadership in health informatics.

Current Roles and Engagement

Judy remains deeply active in the nursing informatics community, serving on **two boards** and **three advisory committees**, representing the use of health IT to improve outcomes for both patients and clinicians.

In Judy's Words

"The evolution of health informatics has always been about people — empowering patients, supporting clinicians, and connecting systems in ways that make care safer and more

effective. It's been an honour to be part of this global journey, and even more rewarding to witness the next generation carry it forward."

Dr Lee Woods, RN, PhD, FAIDH – Australia's Nursing Informatics Powerhouse




8 - Dedicated to advancing nursing informatics through strategic innovation and workforce development.

Her recent achievements are big: leading Queensland's statewide digital maturity assessment; shaping national workforce education and fellowship programs; partnering with First Nations health workers and rural services. Lee's work ensures that digital health isn't just flashy tech—it's safe, equitable, and built with the people it serves.

Why we need more like her: to close the digital skills gap, to design with users, and to embed informatics into every nurse's toolkit.
